COMMITTEE INTRODUCTIONS

Everyone introduced themselves in a round-table fashion.

CELEBRATION OF LEARNING STORIES OF ACADEMIC SUCCESS, CREATIVITY AND IMAGINATION, CITIZENSHIP, RESILIENCY

- T. Malloff, KLPVPA Sorin Vanguard and the Thelonious Monk jazz show was phenomenal. Sorin is a grade 12 student who will graduate this year. He put together an ensemble of community members to put on a 100 year celebration to Thelonious Monk show. It was a packed house with children and community members of all ages. Sorin worked with many seasoned members of the local music community.
- S. Kalabis, KLPVPA Tony provided a workshop for students on how to put up and build a TP. On day 1 he worked with aboriginal students on how to build the PV and on day 2 the workshop was opened up to all students. This workshop increased exposure of First Nations language and their history in the school. The TP will stay up in the school over the next 10 months. Students have shared that they feel this is a scared space, and will take care of it. Sacha enjoyed learning the different approach to teaching the students that he observed of Tony.

STUDENT EXPECTATION

Chair Bendig provided an overview and history of the student expectations in the district.

Student expectations were authored by the Board of Education, and are a guide to everything we do in the district. Embed with intentionality and non-intentionality. Student expectations have become a framework for budget, human resource and planning at every level at the district. Clear understanding of what the Board really wants. Clear and reasonable

expectations.

Superintendent Emeritus Jones lead the group through an exercise to review and provide input on the Student Expectations.

A desire to change the wording of the expectations because of changing language.

Incredible importance of not having too many words out in schools. To find the sweet spot of the boards need to govern and also to hear and listen within the school district.

The measurement piece. How do you gather data that is manageable in schools while also getting good information? What are the metrics for measuring the expectations? Defining the measurement practice will be helpful to those doing the work.

Stretching the data to pre-K to post-secondary. Looking at the descriptive to help measure, and create the data.
