- South Nelson Elementary School

 - Capacity Utilization: 110%
 - Facilities Condition Index: 0.51
 - Deferred Maintenance: \$5.8 MM
 - May be eligible for REP funding (as under the Existing Facilities Plan to build a new South Nelson on Trafalgar ground). Alternatively, South Nelson, already a great facility in the District, may continue to be used as is used currently.





- Trafalgar Middle School
 - Built: 1924
 - Operating Capacity: 575
 - Total Student Enrolment = 368
 - Elementary = 275
 - Secondary = 93
 - Building Metrics:
 - Capacity Utilization: 64%
 - Facilities Condition Index: 0.66
 - Deferred Maintenance: \$11.7 MM
 - May be eligible for REP funding (replacement of South Nelson as under Existing Facilities Plan) or multiple SEP fundings (to fund a larger renovation).





- Central Elementary School Building
 - Built: 1908
 - Operating Capacity: ~200 (Assuming Board Office using 3rd Level)
 - Total Student Enrolment = 180 from two schools:
 - Wildflower
 - Elementary = 130
 - Secondary = 34
 - REACH = 16
 - Building Metrics:
 - Capacity Utilization: ~90% (Assuming Board Office using 3rd Level)
 - Facilities Condition Index: 0.59
 - Deferred Maintenance: \$3.8 MM
 - Board Office Moving in around July, 2019







- A.I. Collinson Elementary School Leased to CSF
 - Built: 1962
 - Building Metrics:
 - Facilities Condition Index: 0.54
 - Deferred Maintenance: \$3.2 MM






- Gordon Sargent Elementary School Leased to School House Day Care
 - Built: 1971

 - Facilities Condition Index: 0.64
 - Deferred Maintenance: \$0.9 MM
