- A. <u>Support for the Framework for Enhancing Student Learning Ministry of Education Policy</u>

Director of Innovative Learning Services, District Principal of Secondary Learning and Innovative Learning, and District Principal of the Early Years and Elementary Learning provided an overview on the Framework for Enhancing Student Learning (FESL). Appendix 10A was referred to for an overview of the function and purpose of School Learning Plans and School Learning Tools.

Director of Innovative Learning provided information on the School Learning Plan Framework which includes the discussion guide, template, and toolkit. He recognized the hard work put into the development from the District Learning Leadership Team and the Learning Leadership Team which is comprised of one School Leader from each of the families of Schools. Furthermore, he noted that the data available to the district will lead to important conversations at schools. This will be evident at the School Learning Tours and will set the district up for the School Planning Day.

Committee Members made comments and asked questions regarding the following topics:

- School Learning Plans: Each school will have a numeracy and literacy goal as well as a specific goal they set for their site

District Principal of Secondary Learning & Innovative Learning and District Principal of the Early Years and Elementary Learning provided an overview of district plans related to literacy and numeracy:

- Working to improve all outcomes for students
- District learning goal for quality and equity is to improve proficiency for all learners
- Committed to focusing on excellence for all learners
- District is investing in our teachers, so they have the resources and tools to help students grow in literacy and numeracy
- Developing a K-12 framework and action plan

A Trustee inquired if there are correlations between the EDI and MDI and numeracy results. Director of Innovative Learning responded that there are different data sets available and they are looking at running correlations. District Principal of the Early Years and Elementary Learning added that EDI was emphasized in the numeracy and literacy report. MDI did not correlate since this is a report that will be summarized through the Inclusive Education Department who will look at that report extensively.

A member from the principals group suggested that the ELP (early learning framework) data set helps tell the whole story of the child in regard to literacy and helps inform school goals.

A Trustee inquired about the budget process and how the data aligns with the school learning goals. The Superintendent noted that in the continued learning reports all schools have action items and those form the goals in moving forward so when it comes to the budget process the enhanced learning process will be done.

## C. <u>April 25<sup>th</sup> District Professional Development Day – Indigenizing the Curriculum</u>

Director of Innovative Learning acknowledged the Professional Development Committee for their hard work.

He provided an overview of the speakers and activities that will happen throughout the day and reiterated that this is an important day for the district.
