Section 600 Review: Finance and Business Operations

The Secretary-Treasurer outlined that all policies in section 600 were reviewed. Policies with minor changes do not require discussion.

The Secretary-Treasurer explained the proposed changes to policies 620 and 621:

- Policy 620: Budget Development, Monitoring and Reporting

A Trustee questioned whether paragraph three of Policy 620 should be removed. This will be reviewed by the Policy Review Committee after field testing.

The Chair suggested to replace the wording “the Board believes” in the first paragraph of policy 620.

- Policy 621: Accumulated Operating Surplus

The Secretary-Treasurer provided information in a response to a Trustees question on the targeted surplus. A surplus allows an organization to make independent decisions in unforeseen circumstances. The estimated 3-5% surplus is a BCASBO guideline that was provided to all school districts in the province and is referring to the operational part of the budget. An operational surplus gets carried over into the next year.
