9. Unfinished Business

A. Enhancing Student Learning Report and School Learning Plans Implementation

Superintendent Smillie outlined that the School Learning Plans were aligned to the new Strategic Plan. Director Eaton and District Principal Malloff presented the Enhancing Student Learning Report as well as learning outcomes. The School Learning Plans are set up to support student success. With a key focus on literacy and numeracy, collected data is used to create instructional plans as well a school learning plans.

Trustees showed their support for the concept of "culture of curiosity".

In a data analysis activity, District Principal Malloff invited attendees to analyze and discuss report card data as well a FSA outcomes over time broken down to Indigenous students, students with Diverse Abilities, as well as all students within the district compared to provincial outcomes. One aspect to celebrate is that, Indigenous students in the district are performing very well compared to the provincial average.

The numeracy spring learning series successfully launched in School District No. 8 (Kootenay Lake) was a success and will be continued.

District Numeracy Teacher Coordinator Brooks invited attendees to participate in an interactive activity "Exploding Dots" which allows learners and educators to explore concepts such as place value, dual numbers, or polynomials in a learning pathway that moves from a concrete to an abstract representation using visualization tools.

The future direction of the district is to inspire and support all students.
